

TNHMC awarded 1172 illegal Registrations in B class

The Tamil Nadu Homoeopathy Medical council keeps a fake, illegal Registration in B class around 1172 physicians, besides 3003 impersonated certificates in B class Registration. It is pertinent to note that the body which is bound to initiate action against the quacks and bogus institutions had awarded Registration in B class against the provisions of the act to meet out the legal

boundaries, simply utilizing the council resolutions

The council keeps three category of practitioners A B and C class. The graduates from the Homoeopathy Medical colleges are registered in A class which is prevailing now also. The B and C class practitioners were one time attempt, issued on certificate of practice by District collectors was closed on

4.5.1976. The Medical Register had been published on 31.5.1978 and copy of the gazette had been forwarded to every entries with facsimile signature of the Registrar. The entries made after is illegal according to the provisions of the act

The gazette publication states that evidently about 1172 practitioners enrolled without valid experience certificates from 1978 to 1989

Facts and Figures

A special test was conducted by the Council for C class registration as provided under the Tamil Nadu Homoeopathy Counsel (syllabus for written tests) regulations 1975. The regulation 4 states that the written test was conducted between May 1975 to 1977 and regulation 5 says that no such tests will be conducted after April 1977. Section 15 of the act will make this amply clear and the entries for C class also completed and published in 31.5.1978 Medical Register

There after the revised publication of entire medical register for A,B,C. every year in the month of February and cross examine the place of practice or residence by the district collectors were grossly neglected. Hence death informations by the district

collectors favoured lot of impersonations committed from council itself. Hence the present authorities hesitate to verify the entries by the District collectors and municipal commissioners. The last entries for the state election B and C is 14117, but considering the life span of a human, 75% would have demised

The Central Council of Homoeopathy pointed out several times to remove the illegal registrations, death list and actions over bogus institutions but successive succeeding members are obstinate in remedying the defects. The legal opinion also stated that illegal registrations will be treated as quacks

The statutory powers conferred by the provisions of the act is abused and conceal

mistakes, tend to blame the Government for not issuing suitable amendments and District collectors as if they have not furnished death list accordance to law. While the entire Medical Register was not published every year in the order of a district and send to the collector to furnish the death, place of profession or residence within the state

The Registrars had been instructed to furnish a list of A class practitioners to the District collectors to make a furious reply to the legal proceedings. While the entire illegal, impersonated entries remains safely because the District Collectors who issued the Certificate of practice will identify the illegal, impersonated entries inserted after 4th May 1974

Dr.G.P. Hahnemann approved Thiru. C. Soundarajan's illegal Registration and impersonations

Thiru.C.Soundarajan, former Registrar i/c of the Tamil Nadu Homoeopathy Medical council enrolled his name as a B Class practitioner illegally after the cut off year bearing the Registration number 12923 with date of Registrations 31.5.1983 after seven years

The act states that B class The Section 15 (1) (b) (ii)

Proves in the prescribed manner to the satisfaction of the council that he has been in regular practice as a practitioner for a period of not less than ten years on the 4th day of may 1974.

He was employee of the council since 1973 and retired from service on 31.7.2012. In 1973 he was about 19 years old, for pursuing 10 years experience he would be around 9 to 10 years old and while he was studying in a elementary school. Hence his professional experience for 10 years is utterly impossible. His certificate of Regular practice issued by the District Collector of Chennai would be a forged document.

Dr.G.P.Hahnemann, who raised doubt over his illegal Registration in early years, is now submissive. He had written a letter to the Police Department with a false statement without transparency of documents which shows his indulgence in illegal and impersonated certificates sales scam

The Registrar states that Government letters dated 10.2.1977 and 19.2.1977 were not available in the office and Dr.G.P. Hahnemann himself not responsive. He misled by the Gazette information Part VI as Part IV, however the archives department was transparent over the

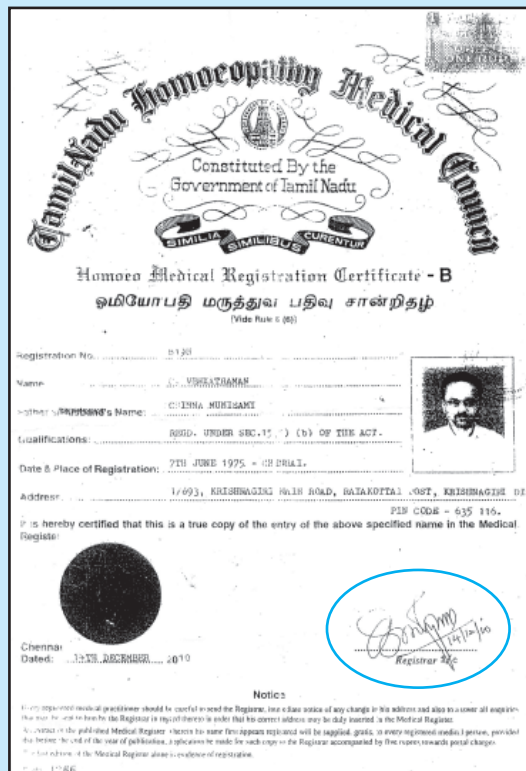
Gazette publication for illegal claiming dated 4.11.1987 which is not possible in accordance with law

While so the affidavit filed civil court states that his name was registered in 1983 and it was published in the Tamil Nadu Government Gazette 2011 and hence it was not possible to publish his name in 1978 Gazette Publication. It is pertinent to note that Dr.T.C.P. Nambiar and Dr.R.Rangasamy were members from 1983 to 1988. The allegation that Dr.C.Soundararajan is not a doctor qualified to be the register also a false complaint also. It is a matter of record that applications were filed prior to 1976 was kept pending with the respective collectorates which necessitated the council to take up the matter with the Government vide their letter dated 10.2.1977. The State Government by its letter dated 19.2.1977 categorically directed the council to receive the certificates from the collectorates in respect of the applications pending prior to 4.5.1976. Accordingly the list was revised and the same was published in the Tamil Nadu Gazette. So far as Dr.C.Soundararajan is concerned 4.11.1987 Gazette, Part-IV Section -1 contains his name in Sl.No.24. The No Objection Certificate also issued from the Council for his part time practice without interfering the official work. Therefore there is no truth in the allegations and the ...
... allegations are made out of spite.

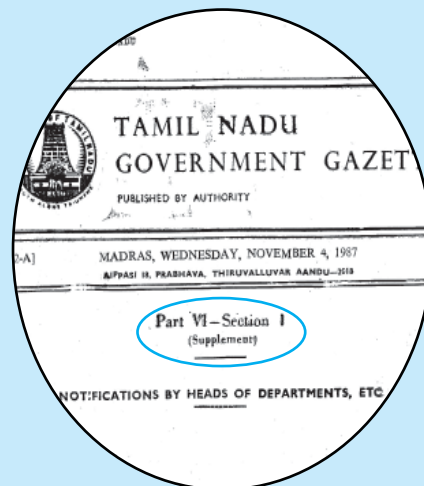

C. Soundarajan and Dr.G.Nirmal since the certificate bearing the serial number 4269 was issued on 21.12.2010 with his knowledge and holds office as advisor of

The council staffs themselves explored the impersonations in B 827, B 8292, B 8198, later B 9140, B 3161 and B 8273, B

4063, B 1929, B 11629 and B 1464 published in TN gazette. While the impersonated entries in the register levels in B 6887, B7986, B 6517, B 5721, B 5811, B 6224, B 8628, B 8098, B 9193, B152, B 1428, B 8417 are in queue for the next publication only during elections

The information on Registration which was supplied earlier by the incumbent Registrar under the designation as public information officer under Right information act, denies that suddenly the he was not designated as PIO, to protect the illegal information
